DESCRIPTION OF WORLD BANK/CEU WORKSHOP

Title: Corporate Governance in Central Europe and Russia

When: 12-17 May 1997

Summary: The Economic Development Institute (EDI) of the World Bank jointly with the Central European University will conduct a one week flagship course on issues of Corporate Governance in Central Europe and Russia. It is intended for professors and researchers in transition economies.

Goals and Expected Impacts: The goal of this session is to advance the participants' understanding of issues and patterns of corporate governance in large, newly privatized firms in selected transition economies. It will examine ownership patterns and the legal and regulatory regime for corporate governance -- including company and securities laws, laws governing financial intermediaries, and laws controlling data collection and enterprise exit in mature market economies and in transition economies, and it will explore how they are influencing or are likely to influence the effectiveness of corporate governance. The participants are expected to integrate this knowledge into their own teaching and research.

Funding: Costs will be shared between EDI and CEU; with the EDI providing for the major share of cost of resource persons and curriculum preparation and the CEU providing local facilities and secondary funding for the travel/lodging of external participants from East/Central Europe.

Role of Curriculum Resource Center: CRC will be able to welcome many academics and professors from the East-Central European region to participate in the World Bank/CEU seminar. Selected participants will be fully sponsored by the CRC. Persons interested in attending the workshop need to send to CRC office a completed application Interested persons are also free to contact our office for any additional information or application assistance. Applicants for this program:

- should be university teachers who are preparing new or revising previously taught courses;
- should submit an outline of a course plan with their application, indicating the kind of materials they would like to gather during their visit;
- should be willing to bring materials from their home university to contribute to the CRC syllabi collection;
- must have sufficient English language ability to participate in discussions and use resource materials.

Curriculum Development Program

Statement of Purpose

The Curriculum Resource Center (CRC) is an outreach program of the Central European University (CEU) which aims to provide curriculum support to teachers and scholars

from the region and increase their integration into the international academic community. It does this by providing greater access to the academic resources available at the Central European University. CRC awards travel grants to university teachers from each country of the region to spend one week in residence at CEU working to develop new – or revise and improve – course syllabi and curriculum plans. Visitors spend their time accessing the syllabi collection, meeting with faculty and students, and using the CEU Library. CRC is funded by a grant from the Higher Education Support Program of the Open Society Institute – Budapest.

Eligibility

- ◆ Any teacher in higher education in the Social Sciences or Humanities, from East-Central Europe or the former Soviet Union, may apply to participate in the CRC Curriculum Development Program.
- Applicants should be currently teaching courses or preparing courses to be taught in the near future.
- All applicants should propose a specific course they would like to develop or improve while at CEU.
- Preference will be given to applicants whose course development plan can clearly benefit from the resources available at CEU.
- Applicants must have sufficient English language competence to make adequate use of library materials and to participate in group discussions.

CRC will cover all costs for:

- ◆ Travel related expenses including airfare, airport transportation, passport, and visa fees.

 Note: All reimbursement requests MUST be accompanied by valid receipts and an exchange rate statement.
- ◆ Hotel, transport and per diem expenses while in Budapest.
- Photocopy costs for duplication of materials at CEU.
- ◆ Book purchase allowance small sum to buy books for home university library.

Application Submission Procedure

- ◆ Applications are FREE and may be copied.
- Application form (or letter containing the same information) may be submitted either directly to CRC
 at the address below, or via a local Soros Foundation office.
- Application deadlines for discipline specific sessions will be announced to Soros Foundation offices periodically.
