Preface

The *Igalo Series* publications launched in 2009, feature articles, essays and contributions by students who have attended the *European Union and Legal Reform* Summer School courses.

Since 2003 European Union and Legal Reform Summer School courses have been organised jointly by the Center for Constitutional Studies and Democratic Development (CCSDD) and the Law Faculty of the University of Belgrade. The CCSDD is a partnership between the Faculty of Law of the University of Bologna and the Johns Hopkins University Paul H. Nitze School of Advanced International Studies (SAIS). The CCSDD carries out research and training in the field of comparative constitutional law, with particular focus on countries undergoing a democratisation process. The Faculty of Law, University of Belgrade is one of the oldest law faculties in Southeastern Europe, with a long tradition of legal research and teaching.

Each year, the Igalo Summer School brings together students and academics from different European countries, particularly participants from Central and East European countries and the Western Balkan region. During the week-long program, various issues and aspects of the European integration processes, constitutional and political transformation and legal reform are deliberated and discussed. Participants who successfully complete the course are awarded seven European ECTS credits.

The *Igalo series* have been in previous years edited by junior faculty members of the School: Sara Pennicino (2009), Francesco Biagi (2010) and Čarna Pištan (2011).

The benefactors of the Summer School in 2012 included: Robert J. Abernethy, the Sonja Valtasaari McHugh Seminar and the Scholarship Program at the University of Bologna. Donors of previous editions include: the Rockefeller Brothers Fund, the Central European Initiative, Provincia di Ravenna and the Fondazione Cassa di Risparmio in Bologna. The organisers are grateful to the sponsors; without their support the realisation of this project would not be possible. Over the years the School has also developed a cooperative relationship with the University of Montenegro (Faculty of Law and Faculty of Political Science).
